## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Spill#481393: On the morning of January 11, 2022, during hot oiling operations on the oil dump line, the line failed resulting in a release in the separator housing within unlined secondary containment. The release caused a fire and in response, incident command was set up and the separator was isolated from the shut-in facility. The fire was naturally extinguished. Further investigation will be conducted to verify the integrity of the line. The impacted soil will be removed and hauled to a COGCC approved disposal facility. A waste characterization sample from the source area will be collected and submitted for analysis of COGCC Table 915-1 constituents. If impacts are confirmed beneath the separator housing, confirmation soil samples will be collected and submitted for the Table 915-1 constituents present in the waste characterization sample.

Spill#481376: During operations, a dumpline became plugged with paraffin and began to transfer all fluids to the pit. Automation on the produced water vessel failed and caused an overflow of the vessel. The site has been shut-in until repairs and cleanup can occur. The release was contained to the pad surface. The impacted soil will be removed and hauled to a COGCC approved disposal facility. Confirmation soil samples will be collected and submitted for laboratory analysis of BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, naphthalene, TPH (C6-C36), pH, EC, SAR, and boron. Additionally, a waste characterization sample from the source area will be collected and submitted for analysis of COGCC Table 915-1 constituents. Background samples for inorganics and metals will be collected and submitted for laboratory analysis as needed.

Thirty-six (36) grab soil samples were collected for analysis of Table 915-1 metals, organics, TPH C6-36, pH, SAR, EC, and boron. Additionally, four (4) soil bores were sampled for BTEX, TPH C6-36, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and naphthalene.
