A site investigation will be conducted pursuant to COGCC rule 911 at the Leonard 3-21J pit. The pit was historically back-filled. Soil samples will be taken and analyzed per Table 915-1 to ensure that this pit does not require any remediation prior to final reclamation on this location.

Based on waste characterization soil sample SS01@7 ft, an amended Table 915-1 soil analysis plan to include TPH C6-36, organics, SAR, EC, pH, boron, arsenic, barium, and lead.
