INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Decommissioning activities were completed at the Bernard E Teets-62N67W /20NESE production facility on December 12, 2022. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soils at one separator, one meter house, one produced water vessel (PWV), one aboveground storage tank (AST), and one emissions control device (ECD) was conducted following removal activities, and soil samples (SEP-B01@3", SEP-B02@3", PW-W01@3', PW-B01@5', and AST-B02@3") were submitted for laboratory analysis to determine if a release occurred. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The facility soil sample and field screening locations are illustrated on Figure 2.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On December 12, 2022, soil samples were collected from the base (PW-B01@5') and west sidewall (PW-W01@3') of the PWV excavation, the separator excavations (SEP-B01@3", SEP-B02@3"), and beneath the AST (AST-B02@3"). The soil samples were submitted for analysis BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), 1,3,5-TMB, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10), TPH - diesel range organics (DRO: C10-C28), oil range organics (ORO: C28-C40), pH, electrical conductivity (EC), sodium adsorption ratio (SAR), and boron using COGCC approved methods for detecting target analytes. Analytical results indicated that constituent concentrations in the soil samples were in compliance with COGCC Table 915-1 standards. Soil analytical results are presented in Tables 2 and 3.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On December 12, 2022, visual inspections and field screening of soils was conducted at three sidewalls of the PWV excavation, one former meter house, one former AST, and one former ECD. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. The soil sample and field screening locations are illustrated on Figure 2. The laboratory analytical report is provided as Attachment A. The field notes and photographic log are provided as Attachment B.

Background soil samples (PW-BG01@2.5', PW-BG01@5' and PW-BG02@2.5', PW-BG02@5') were collected from native material adjacent to the produced water vessel excavation. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Table 3.

Laboratory results indicate that constituent concentrations in the soil samples collected from the base and west sidewall of the PWV excavation (PW-B01@5', PW-W01@3'), separator excavations (SEP-B01@3", SEP-B02@3"), and beneath the former AST (AST-B02@3") were in compliance with COGCC Table 915-1 standards. The excavation areas will be backfilled and contoured to match pre-existing site conditions.

Laboratory results indicate that constituent concentrations in the soil samples collected from the base and west sidewall of the PWV excavation (PW-B01@5', PW-W01@3'), separator excavations (SEP-B01@3", SEP-B02@3"), and beneath the former AST (AST-B02@3") were in compliance with COGCC Table 915-1 standards. Groundwater was not encountered in PWV excavation. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
