INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Decommissioning activities were completed at the Croissant 12&13-20 O SA production facility on March 6, 2023. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soils at one separator, one meter house, one emissions control device (ECD), one produced water vessel (PWV), two dump line locations, and two aboveground storage tanks (AST) was conducted following removal activities, and soil samples (SEP-B01@5', SEP-B02@4', PW-B01@6', PW-E01@3', AST-B02@3", and AST-B04@3") were submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results indicated that constituent concentrations in the soil samples were in compliance with COGCC Table 915-1 standards or within range of analytical variability of site specific background limits. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The facility soil sample and field screening locations are illustrated on Figure 2.

On March 6, 2023, soil samples were collected from the base (PW-B01@6') and east sidewall (PW-E01@3') of the PWV excavation, the separator excavations (SEP-B01@5', SEP-B02@4'), beneath the ASTs (AST-B02@3", AST-B04@3"). The soil samples were submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), 1,3,5-TMB, TPH GRO (C6-C10), DRO (C10-C28), and ORO (C28-C40), pH, EC, SAR, and boron using COGCC approved methods. Analytical results indicated that constituent concentrations in the soil samples were in compliance with COGCC Table 915-1 standards or within range of analytical variability of site specific background limits. Soil analytical results are presented in Tables 2 and 3.

On March 6, 2023, visual inspections and field screening of soils was conducted at three sidewalls of the PWV excavation, one former meter house, one former ECD two dump line potholes, and two former ASTs. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. The soil sample and field screening locations are illustrated on Figure 2. The laboratory analytical reports are provided as Attachment A. The field notes and photographic log are provided as Attachment B.

Background soil samples WH-BG02@3' and WH-BG02@6' were collected from native material adjacent to the Croissant 19-20 wellhead located approximately 0.13 miles northeast of the facility. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters using standard methods appropriate for detecting target analytes in Table 915-1. Analytical results for the background soil samples are presented in Tables 3.

Laboratory results indicate that constituent concentrations in the soil samples collected from the base and east sidewall of the PWV excavation (PW-B01@6', PW-E01@3'), separator excavations (SEP-B01@5', SEP-B02@4'), and from beneath the former AST (AST-B02@3", AST-B04@3") were in compliance with COGCC Table 915-1 standards or within range of analytical variability of site specific background limits. As such, it was determined to be acceptable to leave in place, and no soils were removed. The excavation areas will be backfilled and contoured to match pre-existing site conditions.

Laboratory results indicate that constituent concentrations in the soil samples collected from the base and east sidewall of the PWV excavation (PW-B01@6', PW-E01@3'), separator excavations (SEP-B01@5', SEP-B02@4'), and from beneath the former AST (AST-B02@3", AST-B04@3") were in compliance with COGCC Table 915-1 standards or within range of analytical variability of site specific background limits. Groundwater was not encountered during decommissioning activities. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.

It appears that no further remedial action is necessary at this time and the ECMC approves the closure request.
