Location constructed, well was not drilled and is abandoned.

Inspection #696204061 observed that final reclamation has not been conducted in accordance with 1004 rules; Location has not been recontoured/regraded; fill slopes remain evident and are bare. A berm remains along the southeastern perimeter of the Location; topsoil does not appear to have been replaced; soil surfaces within disturbance appear to be subsoils. Inspection required Operator to comply with 1004 Rules.

It was observed in this inspection that final reclamation of the Location has not been performed in accordance with 1004 Rules; Location remains unchanged since the 9/7/2022 inspection.

CA remains applicable.
