Conducted a follow up inspection at TEP ROCKY MOUNTAIN LLC FEDERAL RMV 133-19 Pad.
Location # 335369 in Garfield County Colorado.

Please refer to Inspection 707800083 conducted on 12/23/2022, previous corrective actions have been completed.

Location is within High Priority/Density Habitat areas.

Location is approximately 30 yards from a drainage that contributes to the Colorado River.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Signs/Marker - Incorrect info on production tank label with a CA date of 09/15/2023
2. Signs/Marker - Wellhead sign has illegible info with a CA date of 08/16/2023
3. Housekeeping - Unused equipment in secondary containment with a CA date of 08/01/2023
4. Equipment - Unmarked deadman/anchor with a CA date of 07/31/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
