This location is within or in close proximity to a Parks and Wildlife (CPW) District with Black Bear, High Priority, NSO, and Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Inspection #702501359 on 5/18/23. All Corrective Actions are still unresolved and previous due dates will remain.

While there during normal operations the following compliance issues were observed:

1. Weeds.
2. Bradenhead still inaccessible or not visible.
3. Gas meter calibration still not visibly displayed.
4. Stormwater BMPs have not been implemented.
