**General Comment:**

COGCC Inspection Report Summary  
 On Thursday 7/13/2023, I, Inspector Scott Ramsey, conducted a routine inspection at TEP PA 22-35, at Location # 335098 in Garfield county Colorado.  
 Any Corrective Actions from previous Inspections that have not been addressed are still applicable.  
 While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management CDPHE regulation 42 and public water system protection. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.  
 During this inspection the following compliance issues were observed:  
 1. Meter calibration card not conspicuously posted.  
 2. Battery signage faded  
 3. One dead man is not properly marked  
 Refer to photograph of observed compliance issue.

A follow up on this site inspection may be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
