Comment:

The well was plugged and abandoned on 9/1/2022. All reclamation must be completed within 12 months of abandonment. There are undesirable weeds at the location that need to be controlled. All gravel and debris will need to be removed. The access road and location will need to be recontoured to the original approximate contours. Soils will need to be decompacted by crossripping to at least 18 inches. Disturbed soils will need to be stabilized to prevent erosion until perennial vegetation is established. BMP's must be implemented in accordance with good engineering practice and must be maintained.
