Comment:

This location does not comply with Rule 1004. Previous inspections (Doc #682504341, 682503006, and 675103782) documented that equipment (e.g. pipe risers) remain on location. At the time of this inspection, pipe risers still remain on location and require removal. It also appears that undesirable vegetation (e.g. Co List C Noxious weed-cheatgrass) has not been managed for and has seeded out. Additionally, the access road to this location will need to be reclaimed. The Operator will need to manage the location for undesirable vegetation, reclaim the access road, and remove equipment in order to come into compliance with Rule 1004.

Corrective Action:

Comply with Rule 1004. Corrective action date is being backdated to when the location was first observed out of compliance.
