Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.

2. TIH with CIBP. Set BP at 6658'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nio perfs @ 6708')

3. TIH with CIBP. Set BP at 3575'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Parkman @ 3625')

4. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement.

5. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations.

6. TIH with tubing to 1500'. RU cementing company. Mix and pump 114 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.

7. Well casing cut and capped per COGCC guidelines at a depth as not to interfere with soil cultivation.
