Corrective Action:	<p>The well location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 7/10/2015. Well pad disturbance and access roads have not been re-contoured or re-graded. Minimal vegetation establishment was observed at both the well pad and well pad access road locations.</p> <p>Operator has performed final reclamation activities at the tank battery location. Germination of desirable species was observed throughout the disturbance area. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p>	Date 07/01/2023
	<p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS.
