Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, one soil sample was submitted for laboratory analysis of metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process. A photolog was submitted on the Subsequent Form 27.

A Site Assessment was conducted on 6/2/2023 to delineate impacted media. Six soil borings were advanced in the area of impacts. BH01 was advanced at the same location as the waste characterization sample FS01 @5.5' to vertically delineate impacts at that location. BH02-BH06 were advanced surrounding BH01 to vertically and laterally delineate impacts identified at FS01 @5.5'. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil, arsenic EC, SAR, pH, and boron. Each of the six soil borings were converted to temporary groundwater monitoring wells. Six groundwater samples were collected and analyzed for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 1-methylnaphthalene, 2-methylnaphthalene, and inorganic parameters. The results of the site assessment will be submitted on a subsequent Form 27.
