**INITIAL ACTION SUMMARY**

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the SHABLE 14-22 wellhead cut and cap. The wellhead will be cut and capped per COGCC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 11/21/2018, and the COGCC was notified on Form 44 Document number 403216829.

**PROPOSED SAMPLING PLAN**

**Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation, and soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
