- Venting health and safety precautions were taken to avoid nuisance and or hazards to the public.
- Form 42 was submitted prior to plugging operations, Form 42 Doc # 403461114. Form 42 was submitted prior to MIRU for plugging operations, Form 42 Doc # 403461112
- Prior to placing plug at 3100', operator waited a sufficient amount of time to confirm static conditions. There was no pressure or fluid migration.
- No fluids or gas migration was present prior to cement plug to surface being set. The plug was cemented to surface with 310 sacks of cement from 285' - 0' and a minimum of 10 sxs of cmt was pumped at surface.
- At least 100' of cement was left in the wellbore for each plug.
- This form 6-SRA addresses all COA's from the Form 6-NOIA.
