OPERATOR COMMENTS AND SUBMITTAL

Comments

The distance to the completed portion of the nearest well in the same unit on the "Spacing & Formations" tab is 0' since this is the only well within the drilling and spacing unit.

The nearest existing or proposed wellbore belonging to another operator is the Anschutz Fed 4-62-11-0108C, API #05-123-46841. The proposed completed interval is greater than 150' from the completed portion of this offset wellbore, therefore a stimulation setback consent is not required. This distance was measured in 3-dimensional space.

The producing intervals of all offset wells owned by other operators within 150' of this well are greater than 150' from the proposed completed interval of this well, therefore a stimulation setback consent is not required.

Attached as OTHER, is the anti-collision analysis which factors in three dimensional measurements as well as gyro surveys performed on some of the offset wellbores. All measurements to offset wellbores were derived from this analysis.
