INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the OCONNELL C31-18 wellhead cut and cap and flowline removal. Approximately 853' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The COGCC will be updated on a subsequent Form 27 with the flowline closure data. The wellhead was cut and capped per COGCC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

Two (2) grab soil sample were collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation, and two (2) subsequent soil samples were collected from a soil boring to vertically delineate impacts at the wellhead. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type during the flowline decommissioning. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, one soil sample was analyzed for metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Visual inspection of the wellhead areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The COGCC Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A Flowline Closure Checklist will be submitted on a subsequent Form 27.

Ten (10) background samples were collected from five discrete boring locations to determine if arsenic is a contaminant of concern at the site. Background samples were collected from depth intervals of 4-ft BGS to correlate with impacts identified during decommissioning and 8-ft to correlate with the depths of confirmatory samples during the remedial excavation. Background concentrations for arsenic at the site range from 0.566 mg/kg to 0.709 mg/kg, which exceed COGCC Table 915-1 Protection of Groundwater and Residential Soil Screening Levels. Based on the exceedances of arsenic above COGCC Table 915-1 standards in background soil, Noble proposes to remove arsenic from the sampling and analysis plan, and limit confirmatory sampling to TPH (C6-36) and Organic Compounds in Soil per COGCC Table 915-1.
