A site investigation was conducted pursuant to COGCC Rule 911 at the FRANK T4N-R64W-S12 L02 Tank Battery location.

Ten (10) grab confirmation soil samples were collected from the produced water vessel excavation, beneath the ground oil tank, and at the separator. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

### Additional Investigative Actions

A Site Assessment was conducted on 5/23/2022 to delineate impacted media. Five soil borings were advanced in the area of impacts. BH01 was advanced at the same location as the waste characterization sample FS02@8' to vertically delineate impacts at that location. BH02-BH05 were advanced surrounding BH01 to vertically and laterally delineate impacts identified at FS01@6'. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil, metals in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Each of the five soil borings were converted into temporary groundwater monitoring wells and sampled for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene. On 11/16/2022, three additional soil borings (BH06-BH08) were advanced to further laterally delineate impacts at the source. Upon receipt of the site assessment lab data, a subsequent Form 27 will be submitted.

Five temporary groundwater monitoring wells were installed to delineate dissolved phase impacts. These wells will be sampled by a third-party consultant on a quarterly basis until four consecutive quarters of compliant groundwater results has been achieved. The groundwater samples will be transported to Summit Scientific for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and groundwater inorganic parameters.
