Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

At approximately 10:30 am on 8/3/2023, the operator came to location and discovered that a rockslide occurred and damaged the tank battery and containment. Upon gauging of the tanks, it was confirmed that approximately 80 bbls of produced water had been released, likely from the sales value parting from the tank due to the rockslide. Severe rain had closed off access to the location. Based on timing of the severe rain, the rockslide occurred at some point between Monday evening of July 31st and Wednesday morning of August 2nd. Clean up operations are underway.
