A site investigation will be conducted pursuant to COGCC rule 911 at the ARISTOCRAT ANGUS63N65W 10SENE (332743) oil and gas location pertaining to the abandonment of the ARISTOCRAT ANGUS 42-10 & 7-2-10 COMMON LINE (12316673\_FL). All other wells and equipment will remain active. See site map exhibit for details.

#### Proposed Soil Sampling

Grab confirmation soil samples will be collected from beneath the flowline start/end points. Potholes will be dug every 250 feet along the flowline path. These observation points will be photographed and field screened. Additional soil samples will be collected when flowline repairs are observed, changes in flow direction, or when there is a change in the flowline material type. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
