General Comment:

On 8/3/23, C-ECMC staff, Kris Neidel was on location to observe Bayless Environmental Contractor collect samples to demonstrate compliance with Location abandonment rules. HRL Environmental staff, Joel Adams was present. Surface owner representative and backhoe operator, Rick Sanny was present. The following areas were investigated with a backhoe and sampled with a hand auger; tank battery, wellhead, treater. The pit was sampled with a hand auger. The Tank Battery had apparent impacted soil. The welded plate was exposed at the wellhead and sampled below cap. Metal debris is still present on the location the following areas; in excavation on NE side of pad, piping leads to the pit on the east side of pad. Random Trash was observed as; pop bottles, tread protectors, etc. Corrective Actions: Remove all debris and Trash, Submit results of samples on Form 27 for Project #30484. It is suggested that the operator plan on delineating the location with an appropriate size rig for rocky conditions. See attached Photos.
