INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Historical impacts were discovered on location beneath a buried line. The extent of the impacts are currently unknown.

A site investigation will be conducted pursuant to COGCC rule 911 at the Hunt 8-60 17A (457131) oil and gas location pertaining to the decommissioning of (13) on-location flowlines. One on-location flowline segment will be replaced. All other wells and equipment will remain active. See site map exhibit for details.

Proposed Soil Sampling

Based on the waste characterization sample analytical results, grab confirmation soil samples will be collected and submitted for laboratory analysis of Table 915-1 TPH C6-C36, Organics, and Arsenic as approved on doc # 403393155. The Barium impact associated with WC-01 (98 mg/kg) was below background soil sample concentrations in WCBK-01 (129 mg/kg).

Grab confirmation soil samples will be collected from beneath the flowline start/end points. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

If groundwater is encountered a grab sample will be collected from the excavation for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Source removal will be scheduled, and confirmation soil samples will be collected. A waste characterization sample was collected at the time of the initial spill assessment. Analytical results indicate Benzene, Toluene, Total Xylene, Napthalene, TVPH-GRO, TEPH-ORO, 1,2,4-TMB, 1,3,5-TMB, 1-Methylnapthalene, 2-Methylnapthalene, and Barium impacts above Table 915-1 GSSL concentration limits and Ethylbenzene and Arsenic impacts above RSSL concentration limits. The Barium impact associated with WC-01 (98 mg/kg) was below background soil sample concentrations in WCBK-01 (129 mg/kg). Based on these results, Civitas North requests to amend the sampling and analysis plan per the approved SAP on doc # 403393155 to only include TPH C6-C36, Organics, and Arsenic.
