#### Operator Comments:

Final reclamation of the Rogers Federal #1 well pad was completed in 2015. Additional seeding operations were completed on the flat area of the reclaim in 2019 and on the cut slopes in 2022. 2023 qualitative and quantitative vegetation surveys show that final reclamation of the well pad disturbance is successful and a self-perpetuating desirable plant community has been reestablished that approximates adjacent reference area composition and cover. Please see the attached vegetation survey report indicating that the reclaimed surface meets Rule 1004 standards. The well pad was not recontoured and the historical access road was left per the surface owner's approved final reclamation variance request (Doc #402525467). The dirt access road remains in a compacted and stable condition, similar to other ranching and BLM roads in the area. The road is not near any water bodies nor does it have a history of erosion problems. Caerus requests COA #2 on the approved variance be waived. The sentence referring to the road as graveled in the variance document was an error and the mining and trucking of over 180 cubic yards of gravel to properly cover the 0.31-mile ranch road does not seem necessary to protect public health, safety, welfare, the environment, or wildlife resources.
