Drilling contractor, Service Drilling Company, contacted Mr. D. V. Rogers, Colorado Oil & Gas Conservation Commission for authority to plug and abandon August 31, 1969. Filled hole with heavy drilling mud from 5405' (total depth) to 1443', set 15 sack cement plug from 1443' to 1373', heavy drilling mud from 1373' to 40' and set 10 sack cement plug from 40' to top of surface casing. Steel cap to be welded on top of surface casing and location restored as soon as conditions permit. Date of work August 31, 1969.
