Corrective Action #1: Remove any remaining debris, abandoned gathering line risers, flowline risers, and equipment from site, CA Date is set at 12/1/2009, three months from plugging.

Corrective Action #2: Conduct additional reclamation in accordance with 1000 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 11/30/2022.

Operator Comment: Pipe has been cut off and covered; all trash and debris has been picked up and equipment cleared from site. Vegetation has been established with total perennial, non-invasive plant cover of at least eighty percent of reference areas. Erosion controls have been implemented to stabilize the seeded soil.
