On Tuesday, 08/15/2023, Inspector Kirby Burchett, conducted a routine field inspection at KT Resources LLC on the Ant Hill County 25-12 well, Location #316336, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Weeds.
2. Gas meter calibration overdue.
3. Stormwater BMPs need implementation.
4. Stained soils around separator.
5. Valve leak on Production tank.
6. Tank berm inadequate.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with COGCC rules.
