Dear Ron:

The leasehold interests held by Caddo Corporation in Section 22, Township 33 South, Range 49 West, 6PM in Baca County, Colorado are composed of two tracts. The first tract is composed of approximately 1104 acres. The second tract consists of a strip of land containing approximately 1.212 acres. The tracts are described on Exhibit "1" to this letter.


All of the mineral interests in tract one are owned by five parties, each of which own an undivided interest in the entire acreage. All of the minerals in tract two are owned by two parties who each own an undivided interest in the entire acreage.

I hope that this answers your questions. If not, please let me know and I will do what I can to get your questions answered.

As we have discussed, we have a drilling rig scheduled to move in within a week to ten days, so we are anxious to have the drilling permit issued as soon as possible. I have spoken with my insurance agent again, and he has informed me that the plugging bond has been approved by the bonding company and has assured me that he will do whatever he can to expedite the delivery of the plugging bond to the Oil and Gas Conservation Commission.
