Summit Midstream (Summit) proposes the following drilling and sampling plan to delineate this spill: four borings outside and inside the original excavation area (north, south, east, center) to laterally and vertically delineate inorganic impacts. For these borings, Summit requests the reduced analyte suite of SAR and EC only. Summit plans to use produced water/operator knowledge for any unaddressed Arsenic and/or pH exceedances.
