Comment: The access road remains per approved variance. The location is recontoured however, vegetation is not progressing in some areas of the location and there are erosion issues. Additional reseedling will need to be performed to establish perennial vegetation cover. There are noxious weeds at the location that had recently been controlled. Some of the weeds have not been fully controlled and additional weed control will need to be performed. Continue to monitor and maintain the location until final reclamation is achieved.
