Following cut and cap operations at the Northglenn State 40-36 wellhead location on July 31, 2023, soil samples were collected from the base of the wellhead cut and cap excavation area (40-36-WH-B01@6'), and from the location where the flowline riser was disconnected at the wellhead (40-36-FL-B01@4'). Based on field observations, PID readings, and preliminary analytical results described herein, sample 40-36-WH-B01@6' was submitted for laboratory analysis of the full ECMC Table 915-1 analytical suite, using standard methods appropriate for detecting the target analytes. Preliminary analytical results indicate that the total petroleum hydrocarbon (TPH) concentration in sample 40-36-WH-B01@6' exceeded the ECMC Table 915-1 standard. Additional analytical results are pending laboratory analysis and final reporting. Excavation and assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 29284 (approved Form 27 Document No. 403369287). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. Soil sample location and field screening data are provided in Table 1. Field notes and a photographic log are provided as Attachment A. The State Notification email is provided as Attachment B.
