On 8/9/2023, DCP Midstream was notified of a potential environmental concern on an above-ground valve on a pig launcher next to the meter shed. The pig launcher's valve/piping and meter shed were permanently removed from the location on 8/15/23. The pipeline was pigged before the removal activities. After the launcher and piping were removed, a cap was welded to the open end of the pipeline. On 8/15/23, DCP's contract roustabout crew alongside a third party environmental consultant began excavation of impacted material around the gas gathering line riser. Approximately 12 cubic yards of impacted material were removed and hauled to Buffalo Ridge Landfill. Confirmation soil samples were collected from the 4 sidewalls and floor of the excavation underneath the riser and submitted to Summit Scientific laboratory in Golden, CO for analysis of CECMC Table 915-1 TPH and Organic Compounds of Concern. Laboratory results are pending and will be provided with the Supplemental Form 19.
