Comment: Previous inspections observed that the outlet to allow stormwater discharge from the working pad surface was not in proper functioning condition. Inspection also noted that additional contouring efforts may be necessary to mitigate stormwater ponding on the Location, and potential impact to stormwater due to production operations.

It was observed in this inspection that the drain has been removed from the perimeter of the WPS to prevent runoff onto the WPS.

Ponding remains apparent.

This CA is being considered resolved, however it is unclear if work to address stormwater issues on the Location has been adequate; a followup inspection will be conducted to determine compliance with ECMC rules.
