Morning Brian,

We’ll need to locate the UPRR 43 Pan Am C #1 well with a magnetometer and stake the location on the surface. The well is location in the SESW of Sec. 25, T1N-R68W, Weld Co., CO. I’ve provided a screen shot below for reference. The staking of the location is necessary to capture pictures to accompany the Form 6’s (well abandonment report) we are required to submit to the ECME (formerly the COGCC). I wanted to let you know since there will be a small wooden stake in the ground at the well’s location.



I am hopeful there are no concerns with doing this; however, if there are, please let me know as soon as you can.

Hi Brian,

I am reaching out regarding a well we have planned to re-enter to properly plug and abandon to prep for future offset horizontal well fracs. The surface is owned by Coors Energy Company. The well, UPRR 43 Pan Am C #1 (API# 05-123-07235), is in the SESW of Sec. 25, T1N-R68W, Weld Co., CO. I've attached a few simple maps for reference.

The proposed operations are currently scheduled for later this year (late Oct.); however the rig schedule is dynamic, and this could change at any time. The well was originally P&A'd in September 1971. The rules and regulations have changed since then and we'd like to re-enter the wellbore to properly plug and abandon the well in accordance with the current rules and regs of the ECMC, formerly the COGCC. Are there any concerns from your end with us accessing the well location to re-enter and plug and abandon the well? Is there a surface/farming tenant on the property? If so, will there be any livestock or crop later in the year during Oct.?

We expect to use approximately 150' radius around the well to perform the re-entry operations. If there are any concerns with the proposed operations or estimated timing, please let me know as soon as reasonably possible. I am happy to provide additional information if needed.
