There is no evidence suggesting impacts are associated with the pit. Form 15 was submitted the pit was intended to be utilized for emergency overflow and not to store produced water. In the event that impacts are discovered, a Form 19 and Supplemental Form 27 will be submitted to outline source removal plans.

An additional Supplemental Form 27 will be submitted prior to conducting the site investigation outlining the sample locations and closure plan.
