Dear Mr. Finnell:

We are in receipt of your letter of October 25, 1957, in which you state that the following wells do not belong to O. M. Hegner or Rangely Oil and Gas Company.

#1 Newton-Government NE SE SE, 11-1N-102W  
#5 Newton-Government NW SE SE, 11-1N-102W  
#6 Newton-Government NW SE SE, 11-1N-102W

We have some confusion in our office due to the fact that there are three other wells also named Newton-Government #1, #5 and #6. However, these three wells are in Section 12 instead of Section 11, but are operated by Rangely Oil and Gas Company. On May 10, 1957, I talked by 'phone to you or someone in your organization and took down information on the three wells listed above, in Section 11. From this information, taken by 'phone, we started a well file on the three wells in Section 11. Now you state in your letter that your firm does not own these wells.

We would like to know if you ever owned these wells in Section 11, and if so, did you sell them to some other operator? You mentioned Jack White Drilling Company in your letter. If this is not the case, did I or the person I talked to by 'phone on May 10, 1957, make an error in the location?
