Any Corrective Actions from previous Inspections that have not been addressed are still applicable. On 8/3/23, C-ECMC staff, Kris Neidel was on location to inspect the State 5 Well. The well was SI at the time of inspection. The following was observed. Pumping unit on a ground with one end on wood. Well has a wired up pump rod as a fence. Flowlines: there is a shallow buried line from the wellhead to tank, There is a 200bbl tank that has NO secondary containment. The soil at the tank battery is Sand. Lack of secondary containment was documented on Inspection 707800362, 5/12/23 and inspection going back to at least 2011, doc 200325508. See attached Photos.
