Operator Comment: SG has attached a map showing the access route to the Federal 11-90-24 1 well pad. The photos that were taken along the access road to the south are not related to this location. It took SG longer than 7 days to pinpoint where these photos were taken, therefore we were unable to submit a factual review request. Photo#05877 is south of SG's field and along a lease road that is operated and used solely by Gunnison Energy. SG does not use this route to access our field. Photo#0576 is taken on a lease road that is not used to access the Federal 11-90-24 1, however, it is used to access the Eck 12-90-1 location that is operated by SG. Due to the nature of the sluffing on the section of the road, SG has contacted a Contractor who is in the process of getting a bid together for the work. SG anticipates to have this sluffing repaired in the next few weeks. Please see the attached map depicting the access route to the Federal 11-90-24 1 and the approximate location of the photos related to the corrective action.
