Procedure Description: Kinder Morgan is seeking approval to abandon the HWD-2 flowline in place prior to commencing final reclamation of the location. A consultation between BLM and Kinder Morgan was conducted on 6/14/23 regarding final reclamation and flowline abandonment at the HWD-2 location. Justification for abandonment in place is as follows: Abandonment in place is less impactful to wildlife resources as the flowline is located in Elk Winter Concentration Area. Vegetative cover has progressed in the disturbed area that the flowline underlies. Attached is a map of the proposed flowline abandonment. The flowline will be abandoned per the following requirements: (1). Evacuate the flowline of any hydrocarbons or produced water to ensure the line is safe and inert (2). Deplete the flowline to atmospheric pressure (3). Cut the flowline's risers to three (3) feet below grade or to the depth of the flowline, whichever is shallower (4). Seal the ends of the flowline below grade (5). Remove above-ground cathodic protection and equipment associated with the riser (6). Ensure flowline depth is greater than 3ft below ground surface.
