Gentlemen:

You are hereby instructed to complete the rehabilitation of the above well location and its associated access road, in accordance with the following items by October 15, 1987.

1. Remove piping, sucker rod, rocker arm, polished rod, etc. from the location.
2. Remove anchors.
3. Remove the oil storage tank.
4. Place the operator name and 1/4 1/4 section on the marker.
5. Remove the powerline.
6. Recontour the well location, the tank location, and that portion of the loadout loop off of the main road.
7. Construct three waterbars on the loadout road where flagged.
8. Seed all disturbed surfaces with the following seed mixture:

<u>Species</u>	<u>Lbs. PLS/Acre</u>
Siberian wheatgrass (P27)	3
Russian wildrye (Vinall)	2
Crested wheatgrass (Nordan)	3



Prepare seedbed by disking or ripping following the natural contour. Drill seed on contour at a depth no greater than 1/2 inch. In areas that cannot be drilled, broadcast at double the seeding rate and harrow seed into soil. Certified seed is recommended.

Fall seeding must be completed after September 1, and prior to prolonged ground frost.

9. Post three signs with the wording "Reseeded Area/Keep Off" next to the existing road at the following locations:
  - a. At edge of recontoured well location.
  - b. On top of ridge at edge of recontoured tank location and loadout loop.
  - c. At bottom end of loadout loop.
