Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6892'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nio perms @ 6942')
4. TIH with CIBP. Set BP at 4367'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Sussex @ 4417')
5. TIH with casing cutter. Cut 4 1/2" casing @ 2400'. Pull cut casing.
6. TIH with tubing to 2450'. RU cementing company. Mix and pump 100 sxs 15.8#/gal CI G cement down tubing. (Stub plug from 2450'-2200')
7. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations.
8. TIH with tubing to 1440'. Mix and pump 100 sxs 15.8#/gal CI G cement down tubing. (Pierre coverage from 1440'-1240')
9. Pick up tubing to 607'. Mix and pump 222 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
10. Well casing cut and capped per COGCC guidelines at a depth as not to interfere with soil cultivation.
