All Spill/Release Point IDs have been closed onto Colorado Oil and Gas Conservation Commission (COGCC) Remediation Project Number 19864. Please refer to COGCC document numbers 2524363, 2524496, 2523460, 2607774, and 2523034 and the Report of Work Completed (ROWC) associated with Form 27 Document 403369156 for details regarding the individual releases, immediate actions taken to abate, investigate, and remediate impacts associated with the historical spills.

See the ROWC associated with Document 403369156 for details regarding site investigation history. On October 20, 2022, Confluence coordinated and oversaw additional remedial excavation to address the benzo(A)pyrene, pH, and arsenic exceedances in the east sidewall of the PH05 excavation. Impacted material from the east sidewall was removed via excavation, and one soil sample was collected from the newly exposed east sidewall. The soil sample was submitted for analysis of COGCC Table 915-1 soil constituents. Analytical results of the PH05 east sidewall soil sample indicate compliance with COGCC Table 915-1 Residential Soil Screening Levels except for arsenic which exceeds at 3.02 milligrams per kilogram (mg/kg).

Caerus submitted COGCC Document 403369156 to request a reduced analyte list of pH and to request alternative allowable limit for arsenic of 7.14 mg/kg. The COGCC approved document 403369156 and the associated requests May 23, 2023.
