General Comment:

On 8/29/2023, Reclamation Specialist Corey McDonough conducted a final reclamation inspection at Chevron Midcontinent LPs Crader 3-3 location in La Plata County, Colorado.

This is a follow up inspection to inspection doc # 693902655.

An approved variance is documented for this location on Doc # 401280618. The condition of approval for the variance is as follows: Final approval of this variance request is contingent upon successful revegetation (to COGCC's 80 percent of a reference area standard) for the reclaimed areas on the well pad and access road, such as the cut and fill slopes. Additionally weeds and stormwater erosion continue to need monitoring and control within the project area until final reclamation is approved.

During this inspection little desirable vegetation was observed on the well pad cut-slopes. Refer to the "Reclamation" section of this inspection report for additional details.

Refer to the photo-documentation of the observed compliance issues attached to this report.

Any corrective action(s) from previous inspections that have not been addressed are still applicable; The "Date of Discovery" is being provided as the corrective action date for all new observed compliance issues.
