Approximately 10 cubic yards of petroleum hydrocarbon impacted soil was released due to a truck rolling over near the intersection of Weld County Road 49 and Weld County Road 30 during transit from the Miller 22-28 facility to Buffalo Ridge Disposal Facility. Assessment activities are ongoing. The assessment details will be summarized in a forthcoming Form 19 supplemental report.
