 Field Inspector Actions:
 On 9-21-2023, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Ryan Bone 15757 Josephine Circle east Thornton CO stated the issues were occurring outside of complainants home. On 9-21-2023, I attempted to make contact with the complainant who indicated that on 9-19-2023 experiencing a loud backfiring noise coming from an oil and gas location. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I found a PU motor on the North York#1 that has an extension on the existing muffler on PU gas powered motor. Noise does not appear to be out of compliance but operator can eliminate disruption to the public by pointing muffler extension toward the HWY instead of subdivision.
