A third-party water hauler left a valve partially open resulting in 10 bbls of fluid to be released inside lined containment and 7 bbls to be released outside containment. The spill was contained to the pad surface and has been controlled. Surface impacts have been removed, however, appear to lead underneath adjacent temporary frac tanks. The tanks will be removed, and source removal will continue.

The Civitas Resources insurance program includes Excess Liability coverage of \$110,000,000 per occurrence and in the aggregate which sits over the sudden and accidental pollution within the General Liability coverage.
