On Friday 9/29/2023, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus K9OU, at Location # 334063 in Garfield county Colorado.
Any Corrective Actions from previous Inspections that have not been addressed are still applicable.
While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.
During this inspection the following compliance issues were observed:
1. Tanks are missing caps
2. Open ended piping for thawing out dump lines on tanks and separators with exhaust from trucks.
