During this inspection, Staff observed that the former production facilities are not progressing towards Rule 1004 regulations and standards as evidenced by undesirable vegetation (e.g. kochia). The former wellhead is located in a cropland which was fallow at the time of this inspection. Additional reclamation activities are required on the former production areas and the wellhead area will be inspected at a future date to verify vegetation establishment.
