Location # 334688 in Garfield County Colorado. Location is within Black Bear/High Priority/Density Habitat areas. While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Signs/Marker - Methanol tank lacks required information with a CA date of 12/01/2023
2. Housekeeping - Construction barrier/wildlife protection needs maintenance with a CA date of 10/09/2023
3. Equipment - Flowline heating insulation open ended with a CA date of 10/09/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
