EVIDENCE OF FINANCIAL CAPABILITY

Foundation Energy Management LLC (FEM) is a manager of energy investments for institutional partners; acquiring, developing, and enhancing domestic oil and gas properties and associated midstream assets. Foundation was created in 2005 and is privately owned, currently operating in good standing in nine states. Foundation has raised \$550 million across seven US direct energy funds. Foundation's financial statements are audited annually by Grant Thornton LLP due to its fiduciary responsibility to its investors and have received unqualifying opinions.

From 2019-2022, Foundation plugged 88 wells across the state and performed environmental and reclamation objectives associated with facility closures. Over the last four years, Foundation has spent \$2,309,481 on plugging and reclamation. This monetary commitment demonstrates that Foundation is capable of spending the ECMC-estimated cost of \$130,000 for well plugging and reclamation for the 1 well on this Out-of-Service designation within a four year period. Foundation will continue to demonstrate wellbore integrity for the wells designated as Out-of-Service until such time as they are plugged.
