Laboratory analytical indicated a historical release occurred along the Greer 23-28 decommissioned flowline. One soil sample exceeded ECMC standards for benzo(a)anthracene at 0.162 mg/kg, benzo(a)pyrene at 0.111 mg/kg, 1-methylnaphthalene at 0.0154 mg/kg, and 2-methylnaphthalene at 0.0303 mg/kg. This location is within the municipality of Keenesburg, Colorado.
